

RESOLUTION NO. 21-53

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF NORTH MIAMI BEACH, FLORIDA, APPROVING AND AUTHORIZING THE CONVERSION OF STAFFING OF THE EASTERN SHORES 35TH AVENUE GUARDHOUSE FROM CERTIFIED LAW ENFORCEMENT PERSONNEL TO SECURITY GUARDS; AND AUTHORIZING THE CITY MANAGER OR DESIGNEE TO TAKE APPROPRIATE STEPS TO IMPLEMENT THIS RESOLUTION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Eastern Shores Security Guard Taxing District (“District”) was created and operated by the Miami-Dade County in 1994/1995 to create additional public improvements and special services; and

WHEREAS the additional public improvement and special services are funded by assessments to the property owners in the District, and

WHEREAS, In December 2017, the residents voted to transfer the governance of the District from Miami-Dade County to the City and this was effectuated in February 2018, and

WHEREAS, In June 2018, the Commission established the Eastern Shores Special Security Guard Special Taxing District Advisory Board to offer advice on service levels and needs; and

WHEREAS, the City provides the governance, assessment, operation and maintenance for the District; and

WHEREAS, the 35th Avenue community guardhouse is staffed by law enforcement personnel and funded by the District; and

WHEREAS, the Advisory Board of the Eastern Shores Special Security Guard Special Taxing District desires to convert the staffing of the 35th Avenue guardhouse from law enforcement personnel to security guards

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Commission of the City of North Miami Beach, Florida.

Section 1. The foregoing recitals are true and correct.

Section 2. The Mayor and City Commission of the City of north Miami Beach hereby authorizes the conversion of staffing of the 35th Avenue guardhouse from law enforcement personnel to security guards.

Sections 3. Funding for these services is at the expense of the 35th Avenue Eastern Shores Special Security Guard Special Taxing District.

Section 4. The City Manager or Designee is authorized to take appropriate actions to implement this Resolution.

Section 5. Effective Date. This Resolution shall be in force and take effect immediately upon its passage and adoption.
