## **RESOLUTION NO. R2021-XX**

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF NORTH MIAMI BEACH, FLORIDA, AUTHORIZING THE CITY MANAGER OR DESIGNEE TO DEVELOP A SMALL BUSINESSES SUPPORT PROGRAM IN THE CITY OF NORTH MIAMI BEACH WHICH WILL PROVIDE SMALL BUSINESSES ACCESS TO EDUCATION, CAPITAL AND BUSINESS SUPPORT SERVICES; DIRECTING THE CITY MANAGER TO CREATE A MONTHLY RECOGNITION PROGRAM FOR SMALL BUSINESSES IN THE CITY OF NORTH MIAMI BEACH; AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS,** small businesses represent 99.7 percent of all businesses having employees in the United States; and

WHEREAS, small businesses employ ½ of the employees in the private sector in the United States; and

**WHEREAS**, small businesses pay 44 percent of the total payroll of the employees in the private, nonfarm product of the gross domestic product; and

**WHEREAS,** small businesses generated 65% of the net new jobs during the last 17 years; and

WHEREAS, small businesses generate 60 to 80 percent of all new jobs annually; and

**WHEREAS,** small business focus on 2 key strategies: deepening relationships with customer and creating value for customers; and

**WHEREAS,** for every \$100 spent with locally owned, independent stores, \$68 returns to the community through local taxes, payroll, and other expenditures; and

**WHEREAS,** 92 percent of customers in the United States agree that the success of small businesses is critical to the overall economic health of the United States; and

WHEREAS, 93 percent of consumers in the United States agree that small businesses contribute positively to the local community by supplying the jobs and generating tax revenue; and

**WHEREAS,** 91 percent of consumers in the United States have small businesses in their community that the consumers would miss if the small business closed; and

**WHEREAS,** 99 percent of consumers in the United States agree that it is important to support the small businesses in their community; and

**WHEREAS,** 90 percent of consumers in the United States are willing to pledge support for a "buy local" movement; and

**WHEREAS**, the Mayor and City Commission wish to developer a small business support program in the City of North Miami Beach, which will provide small businesses access to education, capital, and business support services, and directing the City Manager or Designee to create a monthly recognition program to recognize small businesses in North Miami Beach.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Commission of the City of North Miami Beach, Florida, that:

**Section 1**. Approves and incorporates the foregoing recitals in this Resolution.

<u>Section 2</u>. The Mayor and City Commission authorize the City Manager or Designee to develop a small business support program in the City of North Miami Beach to provide small businesses access to the following:
