RESOLUTION NO. R2021-XX

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF NORTH MIAMI BEACH, FLORIDA, APPROVING AND AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE AN AGREEMENT WITH MULLINGS ENGINEERING SERVICES – LANDSCAPING DIVISION, INC, FOR FIELD RENOVATION SERVICES INCLUDING TOPSOIL REMOVAL, EARTHWORK AND THE PURCHASE AND INSTALLATION OF SOD AT FULFORD AND ULETA PARK IN AN ESTIMATED BUDGETED AMOUNT OF \$75,810.

WHEREAS, in line with the City of North Miami Beach's ("City") Strategic Plan mission of providing excellent municipal services and being a beautiful, safe and livable community in South Florida, the City requires athletic field renovation services including topsoil removal, earthwork and the purchase and installation of sod and at Fulford and Uleta Park ("rehabilitation"); and

WHEREAS, the City identifies contracts competitively solicited and awarded by other governmental agencies as a favorable procurement method which is in line with the City's Strategic Plan mission of providing excellent municipal services in a financially responsible manner; and

WHEREAS, Section 3-2.2 of the City's Code of Ordinances provides that the Chief Procurement Officer has the authority to join with other governmental entities in cooperative purchasing plans, when the best interests of the City would be served; and

WHEREAS, Section 3-4.3 of the City's Code of Ordinances allows for the use of other governmental entities' contracts upon a determination that the supplies, materials, equipment or contractual services needed by the City were purchased using solicitation procedures which are substantially equivalent to the City's Purchasing Guidelines; and

WHEREAS, the Southeast Florida Governmental Purchasing Cooperative Group ("SEFL Coop") consists of forty-five (45) government entities. The group was formed in an effort to provide cost savings and cost avoidances to all entities by utilizing the buying power of combined requirements for common, basic items; and

WHEREAS, the City of Boynton Beach, on behalf of SEFL Coop, issued Invitation to Bid No. 033-2730-18/IT "Sod and Sod Installation" ("ITB"), and on October 1, 2018, Mullings Engineering Services, LLC ("Mullings") was awarded the ITB for a one (1) year term with the option to renew for three (3) additional one (1) year periods; and

WHEREAS, the City of Pembroke Pines, issued Invitation to Bid No. PSPW-20-07, "Sod and Sod Installation / Removal Services" ("IFB") and on March 17, 2021, Mullings was awarded the ITB for one (1) year with the option to renew for three (3) additional one (1) year periods; and

WHEREAS, in accordance with the terms and conditions of the ITB's, Mullings has provided the City with a quote for the field renovation in an estimated amount of \$75,810; and

WHEREAS, Section 3-3.14 of the City's Code of Ordinances provides that contracts in excess of fifty thousand dollars (\$50,000.00) shall be awarded by the City Commission; and

WHEREAS, the City Manager, the Parks and Recreation Director and the Chief Procurement Officer recommend that the City Commission approve and authorize the City Manager or designee to enter into an agreement with Mullings Engineering Services, LLC. for field renovations in an estimated budgeted amount of \$75,810; and

WHEREAS, the Mayor and City Commission believe it is in the best interests of the City to authorize the City Manager or designee to enter into an agreement with Mullings Engineering Services, LLC. for field renovations, in an estimated budgeted amount of \$75.810.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Commission of the City of North Miami Beach, Florida:

Section 1. The aforementioned recitals are true and correct.

Section 2. The Mayor and City Commission hereby authorize the City Manager or designee to enter into an agreement with Mullings Engineering Services, LLC for field renovation services including topsoil removal, earthwork and the purchase and installation of sod and at Fulford and Uleta Park, in a form acceptable to the City Attorney, in an estimated budgeted amount of \$75,810.

Section 3. This resolution shall take effect immediately upon approval.
