

RESOLUTION NO. R2021

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF NORTH MIAMI BEACH, FLORIDA, APPROVING AND AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE AN AGREEMENT WITH A TO Z METAL FABRICATION FOR METAL FABRICATION AND WELDING SERVICES, INC. IN AN ESTIMATED ANNUAL BUDGETED AMOUNT OF \$85,000.00 AND TO RENEW THE AGREEMENT SUBJECT TO APPROVED BUDGET APPROPRIATION AND AVAILABILITY OF FUNDS, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, in line with the City of North Miami Beach's ("City") Strategic Plan of providing excellent municipal services and a high performing City organization providing exceptional; water quality, the Public Utilities Department ("NMB Water") provides water services within the City of North Miami Beach, Aventura, Miami Gardens, Sunny Isles and parts of Unincorporated Miami-Dade County; and

WHEREAS, the City identifies contracts competitively solicited and awarded by other governmental agencies as a favorable procurement method which is in line with the City's Strategic Plan mission of providing excellent municipal services in a financially responsible manner; and

WHEREAS, The City of Hollywood has established a contract for metal fabrication and Welding Services, Contract Number F-4623-19RL. A to Z Metal Fabrication, Inc. ("A to Z") was awarded for three (3) years, with two one-year renewal terms effective December 5, 2019 through December 4, 2024.

WHEREAS, Section 3-4.3 of the City's Code of Ordinances allows for the use of other governmental entities' contracts upon a determination that the supplies, materials, equipment or contractual services needed by the City were purchased using solicitation procedures which are substantially equivalent to the City's Purchasing Guidelines; and

WHEREAS, Section 3-3.14 of the City's Code of Ordinances provides that contracts in excess of fifty thousand dollars (\$50,000.00) shall be awarded by the City Commission; and

WHEREAS, the City Manager, the NMB Water Director and the Chief Procurement Officer recommend that the City Commission approve and authorize the City Manager or designee to enter into an agreement with A to Z Metal Fabrication, Inc. for metal fabrication and welding services in an estimated annual budgeted amount of \$85,000.00; and

WHEREAS, the Mayor and City Commission believe it is in the best interests of the City to authorize the City Manager or designee to enter into an agreement with A to Z Metal Fabrication, Inc. for metal fabrication and welding services in an estimated budgeted amount of \$85,000.00.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Commission of the City of North Miami Beach, Florida:

Section 1. The aforementioned recitals are true and correct.

Section 2. The Mayor and City Commission hereby authorize the City Manager or designee to enter into an agreement with A to Z Metal Fabrication, Inc. for metal fabrication and welding services, in a form acceptable to the City Attorney, in an estimated annual budgeted amount of \$85,000.00 and to renew the agreement subject to the approved budget appropriation process.

Section 3. This resolution shall take effect immediately upon approval.
