Description of Change:

On August 4, 2020, the Mayor and City Commission made the decision to terminate the Operation and Maintenance contract with Jacobs and directed the City Manager to start the transition and gain control of the Utility Department. This action includes the hiring/procuring of all the necessary resources to re-start the operating and maintneance of the Utility Department.

The original contract request amount was for \$47,000.00. We are requesting to increase the amount to \$51,000.00 to the account 410904-533520 (\$75,000.00) and increase the amount to \$10,000.00 to the account 410901-533520(\$33,000.00). We are requesting to increase the amount to \$108,000.00 to provide all the goods/services needed until the end of the 2021 fiscal year. This increase will be used to buy instruments, parts, chemicals/supplies in support of compliance monitoring for the Water Plant.

Therefore, a change order will be needed in order to proceed.

No increase in contract price shall be approved unless there are sufficient funds available for such purpose
