RESOLUTION OF THE MAYOR AND **CITY** COMMISSION OF THE CITY OF NORTH MIAMI BEACH, FLORIDA, **APPROVING** THE **PURCHASE** INSTALLATION OF ARTIFICIAL TURF FOR THE PATRICIA A. MISCHON PARK ATHELETIC FIELDS AT THE ESTIMATED COST OF \$1,920,000; AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE AN AGREEMENT WITH FIELDTURF USA, INC. TO PROVIDE SAME; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of North Miami Beach ("City") Parks and Recreation Department provides playing fields for recreation, practice and play consistent with the mission of the City; and

WHEREAS, the Patricia A. Mischon Park athletic fields are used extensively throughout the year; and

WHEREAS, Section 3-4.3 of the City's Code of Ordinances allows for the use of other governmental entities' contracts upon a determination that the supplies, materials, equipment or contractual services needed by the City were purchased using solicitation procedures which are substantially equivalent to the City's Purchasing Guidelines; and

WHEREAS, Sourcewell (formerly NJPA – National Joint Powers Alliance) issued RFP #060518 for "Athletic Surfacing with Related Materials, Supplies, Installation and Services" and the contract was awarded to FieldTurf USA, Inc. for a four-year period, beginning August 7, 2018 and ending August 7, 2022; and

WHEREAS, the Procurement Management Division, in providing its due diligence, reviewed substantially similar governmental contracts and has determined that it is prudent to piggyback and utilize the resulting agreement with FieldTurf USA, Inc; and

WHEREAS, Section 3-3.14 of the City's Code of Ordinances provides that contracts in

excess of fifty thousand dollars (\$50,000.00) shall be awarded by the City Commission; and

WHEREAS, the City has solicited a proposal from FieldTurf USA, Inc., an approved vendor through Sourcewell, to furnish and install athletic field turf at the Patricia A. Mischon Park, and FieldTurf USA, Inc., has agreed to provide the services at an estimated cost of \$1,920,000; and

WHEREAS, the City Manager, along with the Director of Parks and Recreation, Capital Projects Manager, and the Chief Procurement Officer, recommend that the City Commission approve and authorize the City Manager or designee to enter into an agreement with FieldTurf USA, Inc. to furnish and install artificial turf at an estimated cost of \$1,920,000; and

WHEREAS, the Mayor and City Commission believe it is in the best interests of the City to authorize the City Manager or designee to enter into an agreement with FieldTurf USA, Inc., to furnish and install artificial turf at an estimated cost of \$1,920,000.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Commission of the City of North Miami Beach, Florida that:

Section 1. The aforementioned recitals are true and correct.

Section 2. The Mayor and City Commission hereby approve the purchase and installation of artificial turf at an estimated cost of \$1,920,000 and authorize the City Manager or designee to enter into an agreement with FieldTurf USA, Inc., to furnish and install the artificial turf, after review by the City Attorney's Office.

Section 3. This Resolution shall take effect immediately upon approval.
