A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF NORTH MIAMI BEACH, FLORIDA, APPROVING AND AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE AN AGREEMENT WITH TYLER TECHNOLOGIES FOR TYLER EXECUTIME SOFTWARE AND THE BIOMETRIC TIME AND ATTENDANCE SYSTEM IN AN AMOUNT NOT TO EXCEED \$125,228.00; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, in line with the Ek{ "qh"P qty "O kco k"Dgcej øu"\*õEk{ ö+ Strategic Plan of providing excellent municipal services and a high performing City organization providing great customer services, the City needs to purchase ExecuTko gøu"Vqwej uetggp"32<Dkqo gvtkes and Prox Readers and increase the ExecuTime Time & Attendance licenses for the administration; and

This integration will reduce and eliminate dual entry between timekeeping and payroll, avoids managing two sets of security, and eliminates the need to manipulate interface files; and

WHEREAS, ExecuTio gau'Touchscreen 10: Biometrics and Prox Readers will provide the Ekx{au'departments the capability to efficiently track attendance of employees by simplifying the clocking-in and out process with the use of fingerprints; and

WHEREAS, Tyler Technologies is the sole source provider of ExecuTime; and

WHEREAS, Section 3-607 'qh'y g'Ek{øu'Eqf g'qh'Qtf kpcpegu'r tqxkf gu'y cv'r wtej cugu'qh'y g'' following materials and services shall be exempt from the bidding process and subject to the spending limitations provided in subsection 3-3.14, a. Sole-source supplies and services, such as unique, patented, or franchised supplies or services, are exempt if the Purchasing Agent determines, after conducting a good faith review of available sources, that the particular supply or service is available from only one (1) source; and
