A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF NORTH MIAMI BEACH, FLORIDA, APPROVING THE AWARD OF INVITATION TO BID ITB-21-014-MC – NE 35TH AVENUE ROADWAY & WATER MAIN IMPROVEMENTS CONSTRUCTION PROJECT TO DAVID MANCINI & SONS, INC.; AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE AN AGREEMENT WITH DAVID MANCINI & SONS, INC., AND EXPEND A BUDGETED AMOUNT NOT TO EXCEED \$4,700,288.00; AND PROVIDING FOR AN EFFECTIVE DATE.

- WHEREAS, in line with the City of North Miami Beach's ("City") Strategic Plan of providing excellent municipal services and a high performing City organization; and
- WHEREAS, the City embarked on a joint project between the Public Works and Water departments for roadway and water system improvements in the Eastern Shores neighborhood; and
- **WHEREAS**, the City issued Invitation to Bid No. ITB-21-014-MC "NE 35th Avenue Roadway & Water Main Improvements Construction Project ("ITB"); and
- **WHEREAS**, ITB notices were electronically mailed to over 5,000 potential, local and national suppliers as well as advertised on the City's website; and
 - WHEREAS, on July 12, 2021, three bids were received; and
- WHEREAS, Procurement Management Division conducted an administrative review of the apparent lowest submissions and deemed them responsive and responsible; and
- WHEREAS, NMB Water and Public Works Departments reviewed the apparent lowest responsive and responsible bid from David Mancini & Sons, Inc. and recommend award in an amount of \$4,700,288.00; and
- **WHEREAS,** Section 3-3.14 of the City's Code of Ordinances provides that contracts in excess of fifty thousand dollars (\$50,000.00) shall be awarded by the City Commission; and
- WHEREAS, the City Manager conducted his own due diligence and concurs with the recommendation to award of the ITB to the lowest responsive and responsible bidder, David Mancini & Sons, Inc., in an amount of \$4,700,288.00; and
- **WHEREAS**, the Mayor and City Commission find it to be in the best interests of the City to award the ITB to David Mancini & Sons, Inc. and authorize the City Manager or designee to execute an agreement, in an amount of \$4,700,288.00.
- **NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Commission of the City of North Miami Beach, Florida:
 - **Section 1.** The aforementioned recitals are true and correct.

Section 2. The Mayor and City Commission approve the award of the ITB to David Mancini & Sons, Inc., in an amount not to exceed \$4,700,288.

Section 3. The Mayor and City Commission hereby authorize the City Manager or designee to approve an agreement with David Mancini & Sons, Inc., in an amount not to exceed \$4,700,288.

Section 4. This Resolution shall take effect immediately upon approval.
