A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF NORTH MIAMI BEACH, FLORIDA, APPROVING THE AWARD OF INVITATION TO BID ITB-21-035-MC – "HONEY HILL WATERMAIN SYSTEM REHABILITATION CONSTRUCTION PROJECT" TO MASTER ROAD FINISHERS CORP.; AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE AN AGREEMENT WITH MASTER ROAD FINISHERS CORP., AND EXPEND A BUDGETED AMOUNT NOT TO EXCEED \$1,234,519.60; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, in line with the City of North Miami Beach's ("City") Strategic Plan of providing excellent municipal services and a high performing City organization providing exceptional water quality, Public Utilities Department ("NMB Water") provides water service within the City of North Miami Beach, Aventura, Miami Gardens, Sunny Isles and parts of unincorporated Miami-Dade County; and

WHEREAS, NMB Water requires a contractor for the installation of replacement water lines in a residential neighborhood; and

WHEREAS, the City issued Invitation to Bid No. ITB-21-035-MC "Honey Hill Watermain System Rehabilitation Construction Project" ("ITB"); and

WHEREAS, ITB notices were electronically mailed to over 5,000 potential, local and national suppliers as well as advertised on the City's website; and

WHEREAS, on July 8, 2021, seventeen bids were received; and

WHEREAS, Procurement Management Division conducted an administrative review of the apparent lowest submissions and deemed them responsive and responsible; and

WHEREAS, the NMB Water Department reviewed the apparent lowest responsive and responsible bid from Master Road Finishers Corp., and recommend awarding the bid in an amount of \$1,234,519.60; and

WHEREAS, Section 3-3.14 of the City's Code of Ordinances provides that contracts in excess of fifty thousand dollars (\$50,000.00) shall be awarded by the City Commission; and

WHEREAS, the City Manager conducted his own due diligence and concurs with the recommendation to award of the ITB to the lowest responsive and responsible bidder, Master Road Finishers Corp., in an amount of \$1,234,519.60; and

WHEREAS, the Mayor and City Commission find it to be in the best interests of the City to award the ITB to Master Road Finishers Corp. and authorize the City Manager or designee to execute an agreement, in an amount of \$1,234,519.60.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Commission of the City of North Miami Beach, Florida:

Section 1. The aforementioned recitals are true and correct.

Section 2. The Mayor and City Commission approve the award of the ITB to Master Road Finishers Corp., in an amount not to exceed \$1,234,519.60.

Section 3. The Mayor and City Commission hereby authorize the City Manager or designee to execute an agreement with Master Road Finishers Corp., in an amount not to exceed \$1,234,519.60.

Section 4. This Resolution shall take effect immediately upon approval.
