A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF NORTH MIAMI BEACH, FLORIDA, APPROVING THE SELECTION OF AETNA, INC. AS THE PROVIDER FOR HEALTH INSURANCE COVERAGE FOR CITY EMPLOYEES; AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH AETNA FOR HEALTH INSURANCE COVERAGE IN THE ESTIMATED ANNUAL AMOUNT OF \$5,590,234.00; AND TO IMPLEMENT THE PROGRAM; AND PROVIDING AN EFFECTIVE DATE.
