RESOLUTION NO. X2021

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF NORTH MIAMI BEACH, FLORIDA, APPROVING AND AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE AN AGREEMENT WITH AFTON PUMPS, INC FOR RO PUMP AND MOTOR IN AN ESTIMATED BUDGETED NOT TO EXCEED AMOUNT OF \$108,767; AND PROVIDING FOR EFFECTIVE DATE.

WHEREAS, in line with the City of North Miami Beach's ("City") Strategic Plan of providing excellent municipal services and a high performing City organization providing great customer services, the City and Afton Pumps Inc., enter into an agreement for the purchase of a spare Afton Floridan Well Pump and Motor for the RO treatment system; and

WHEREAS, Afton Pumps, Inc. is the sole source provider of the Model VST 10x12-3 pump; and

WHEREAS, Section 3-4.5 of the City's Code of Ordinances provides that purchases of the following materials and services shall be exempt from the bidding process and subject to the spending limitations provided in subsection 3-3.14, a. Sole source purchases and Sole-source supplies and services, such as unique, patented, or franchised supplies or services, are exempt if the Purchasing Agent determines, after conducting a good faith review of available sources, that the particular supply or service is available from only one (1) source; and

WHEREAS, Section 3-3.14 of the City's Code of Ordinances provides that contracts in excess of Fifty Thousand Dollars (\$50,000.00) shall be awarded by the City Commission; and

WHEREAS, the City Manager conducted his own due diligence and concurs with the recommendation of the NMB Water Director and the Chief Procurement Officer to enter into an agreement with Afton Pumps, Inc. for the purchase of a spare Afton Floridan Well Pump and Motor for the RO treatment system to purchase like equipment to the existing pumps owned and operated by the City in the not to exceed total amount of \$108,767.00; and

WHEREAS, the Mayor and City Commission determine it is in the best interests of the City to enter into an agreement with Afton Pumps Inc, to provide for the purchase of a spare Afton Floridan Well Pump and Motor for the RO treatment system for a total amount not to exceed \$108,767.00.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Commission of the City of North Miami Beach, Florida:

- **Section 1**. The aforementioned recitals are true and correct.
- **Section 2**. The Mayor and City Commission hereby authorize the City Manager or designee to enter into an agreement, in a form acceptable to the City Attorney, with Afton Pumps Inc, to provide for the purchase of a spare Afton Floridan Well Pump and Motor for the RO treatment system for a total amount not to exceed \$108,767.00.

Section 3. This resolution shall take effect immediately upon approval.
