

**RESOLUTION NO. R2022-XX**

**A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF NORTH MIAMI BEACH, FLORIDA, APPROVING AND AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE AN AGREEMENT WITH GAME TIME, INC. AND AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXPEND THE ESTIMATED EXPENDITURE OF \$351,989.69; PROVIDING THE CITY MANAGER AND CITY ATTORNEY WITH THE AUTHORITY TO DO ALL THINGS TO EFFECTUATE THIS RESOLUTION; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the City of North Miami Beach (“City”) Parks and Recreation Department provides outdoor parks with playgrounds and related products for recreation use with the mission of the City; and

**WHEREAS**, the playground at Highland Village is used by the community and visitors throughout the year; and

**WHEREAS**, Section 3-4.3 of the City’s Code of Ordinances allows for the use of other governmental entities’ contracts upon a determination that the supplies, materials, equipment or contractual services needed by the City were purchased using solicitation procedures which are substantially equivalent to the City’s Purchasing Guidelines; and

**WHEREAS**, OMNIA Partners (National IPA and U.S. Communities) issued RFP #269-2017-028 for “Playground Equipment, Outdoor Fitness Equipment, Site Accessories, Surfacing, and Related Products and Services” and Game Time, Inc. (“Game Time”) has been awarded a five (5) year contract (contract number 2017001134) from effective date July 1, 2017 through June 30, 2022 with an option for two (2) additional two-year terms; and

**WHEREAS**, the Procurement Management Division, in providing their due diligence, reviewed substantially similar governmental contracts and has determined that it is prudent to piggyback and utilize the resulting agreement with Game Time; and

**WHEREAS**, Section 3-3.14 of the City’s Code of Ordinances provides that contracts in excess of fifty thousand dollars (\$50,000.00) shall be awarded by the City Commission; and

**WHEREAS**, the City has solicited a proposal from Game Time, an approved vendor through OMNIA Partners, to furnish and install a playground, swings, safety surfacing, and related products at an estimated expenditure of \$351,989.69; and

**WHEREAS**, the City Manager, along with the Director of Parks and Recreation, and the Chief Procurement Officer recommend that the City Commission approve and authorize the City Manager or designee to enter into an agreement with Game Time for playground, swings, safety surfacing, and related products at an estimated expenditure of \$351,989.69; and

**WHEREAS**, the Mayor and City Commission believe it is in the best interests of the City

to authorize the City Manager or designee to enter into an agreement with Game Time, Inc. for the purchase and installation of playground, swings, safety surfacing, and related products at an estimated expenditure of \$351,989.69.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Commission of the City of North Miami Beach, Florida:

**Section 1.** The aforementioned recitals are true and correct.

**Section 2.** The Mayor and City Commission hereby authorize the City Manager or designee to enter into an agreement with Game Time, Inc. for the purchase and installation of a playground, swings, safety surfacing, and related products at the Highland Village playground at an estimated expenditure of \$351,989.69.

**Section 3.** The Mayor and City Commission hereby authorize the City Manager and City Attorney with the authority to do all things necessary to effectuate this resolution.

**Section 4.** This resolution shall take effect immediately upon approval.
