A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF NORTH MIAMI BEACH, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE A TURF AND LANDSCAPE MAINTENANCE AGREEMENT, INCLUDING RENEWAL **OPTIONS**, BETWEEN THE CITY OF NORTH MIAMI BEACH AND THE FLORIDA DEPARTMENT OF **TRANSPORTATION** ("FDOT"); PROVIDING THE TERMS AND CONDITIONS FOR THE MAINTENANCE **RESPONSIBILITIES AND FOR** THE REIMBURSEMENT OF TURF AND LANDSCAPE MAINTENANCE ELEMENTS FROM FDOT TO THE CITY OF NORTH MIAMI BEACH.

WHEREAS, the Florida Department of Transportation ("FDOT") has jurisdiction of and maintains State Roads in the City of North Miami Beach, Florida ("City"); and

WHEREAS, on June 20, 2019, the City entered into a maintenance agreement with FDOT for turf and landscape maintenance of those roadside areas and medians within the corporate limits of the City ("2016 Agreement"), which was initially for a term of one year, and only permitted for two one-year renewals, the last of which expires on June 21, 2019; and

WHEREAS, because the 2019 Agreement is set to expire and does not permit for any further renewals, the City wishes to enter into a new agreement with FDOT for the same purpose and with essentially the same terms; and

WHEREAS, the Agreement with FDOT provides that FDOT shall compensate the City up to fifty-three thousand five hundred and fifty-six dollars (\$53,556.00) annually for maintenance of the roadside areas and medians described in the Agreement (Exhibit "A"); and

WHEREAS, the Agreement will be for a term of one (1) year, with an option to renew twice; and

WHEREAS, the Mayor and City Commission of the City of North Miami Beach desire to maintain the median strips and roadside areas within the corporate limits of the City, and authorize the City Manager or designee to execute the turf and landscape maintenance agreement and options to renew, in substantially the attached form (Exhibit "A") between the City and FDOT.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Commission of the City of North Miami Beach, Florida:

Section 1. The aforementioned recitals are true and correct.

Section 2. The Mayor and Commission of the City of North Miami Beach, Florida, hereby direct and authorize the City Manager, or designee, in a form acceptable to the City Attorney, to execute the turf and landscape maintenance agreement and options to renew, in substantially the attached form (Exhibit "A") between the City of North Miami Beach and FDOT.

Section 3. This resolution shall take effect immediately upon approval.
