

RESOLUTION NO. R2022-XX

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF NORTH MIAMI BEACH, FLORIDA, APPROVING THE AWARD OF INVITATION TO BID NO. ITB-22-024-SG – “LANDSCAPE IMPROVEMENTS SR860 / NE 183rd STREET FROM NE 6TH AVENUE TO NE 10TH AVENUE”; AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE AN AGREEMENT WITH THE LOWEST RESPONSIVE AND RESPONSIBLE BIDDER, VISUALSCAPE, INC. AND FURTHER AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXPEND AN ESTIMATED BUDGETED AMOUNT OF \$247,355; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of North Miami Beach (“City”) issued an Invitation to Bid No. ITB-22-024-SG (“ITB”) for “*Landscape Improvements SR860 / NE 183rd Street From NE 6th Avenue to NE 10th Avenue*”; and

WHEREAS, pursuant to the ITB, the selected contractor is required to provide all necessary labor, equipment, materials and expertise required for the implementation and completion of the landscape improvements, including but not limited to: to the removal, installation and watering/maintenance of various trees and shrubs along a highly traveled throughfare at the north west entrance of North Miami Beach, located at SR860 / NE 183rd Street from NE 6TH Avenue to NE 10th Avenue; and

WHEREAS, electronic notices were posted on the City’s website and Bidsync.com, and notifications were sent to over 10,000 potential local and national vendors, and on April 14, 2022, five (5) bids were received by the City; and

WHEREAS, the Public Works and Procurement Management Departments reviewed the lowest responsive and responsible bid from VisualScape, Inc, (“VisualScape”) and recommend award of the ITB to VisualScape in an estimated budgeted amount of \$274,355; and

WHEREAS, Section 3-3.14 of the City’s Code of Ordinances provides that contracts in excess of fifty thousand dollars (\$50,000.00) shall be awarded by the City Commission; and

WHEREAS, the City Manager conducted his own due diligence and concurs with the recommendation to award of the ITB to the lowest responsive and responsible bidder, VisualScape, Inc., in an estimated budgeted amount of \$274,355; and

WHEREAS, the Mayor and City Commission find it to be in the best interests of the City to award the ITB to VisualScape and authorize the City Manager or designee to execute an agreement, in an estimated budgeted amount of \$274,355.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Commission of the City of North Miami Beach, Florida:

Section 1. The foregoing recitals are true and correct.

Section 2. The Mayor and City Commission hereby approve and award Invitation to Bid No. ITB-22-024-SG *Landscape Improvements SR860 / NE 183rd Street* to VisualScape, Inc., and authorize and direct the City Manager or designee to execute an agreement, in a form acceptable to the City Attorney, with VisualScape, Inc, for *Landscape Improvements SR860 / NE 183rd Street From NE 6th Avenue to NE 10th Avenue*, in an estimated budgeted amount of \$274,355.

Section 3. This resolution shall take effect immediately upon approval.
