

RESOLUTION NO. R2022-

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF NORTH MIAMI BEACH, FLORIDA, APPROVING AND AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE AN AGREEMENT WITH FLORIDA CDI, LLC DBA CHRISTMAS DESIGNERS TO FURNISH, DELIVER AND INSTALL HOLIDAY LIGHTING AND DECOR; AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXPEND THE ESTIMATED EXPENDITURE OF \$75,500 AS APPROVED IN THE BUDGET APPROPRIATION PROCESS; PROVIDING THE CITY MANAGER OR DESIGNEE WITH THE AUTHORITY TO DO ALL THINGS NECESSARY TO EFFECTUATE THIS RESOLUTION; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, in keeping with the City of North Miami Beach’s (“City”) Strategic Plan of providing excellent municipal services and being a beautiful, safe and livable community in South Florida, the Parks and Recreation Department facilitates the annual holiday lighting and decor display at City facilities and throughout the City; and

WHEREAS, the holiday lighting and decor display is aesthetically pleasing, providing enjoyment for residents and visitors throughout the City;

WHEREAS, the City has solicited the assistance of Christmas Designers for the purchase of holiday lighting and décor at City facilities and throughout the City; and

WHEREAS, the Town of Davie issued and awarded Request for Proposal No. JA-20-87 “Holiday Lighting Services to Christmas Designers for a two-year term with two additional one year options to renew, effective September 2, 2020; and

WHEREAS, Section 3-4.3 of the City Code allows for the use of other governmental entities’ contracts upon a determination that the supplies, materials, equipment or contractual services needed by the City were purchased using solicitation procedures which are substantially equivalent to the City’s Purchasing Guidelines; and

WHEREAS, Section 3-3.14 of the City Code provides that contracts in excess of fifty thousand dollars (\$50,000.00) shall be awarded by the City Commission; and

WHEREAS, the City Manager, the Parks & Recreation Director and the Chief Procurement Officer recommend that the City Commission approve and authorize the City Manager or designee to enter into an agreement with Christmas Designers for the purchase of holiday lighting and décor at City facilities and throughout the City in an estimated amount of \$75,500; and

WHEREAS, the Mayor and City Commission believe it is in the best interests of the City to authorize the City Manager or designee to enter into an agreement with CDI Enterprises, LLC dba Christmas Designers for the purchase holiday lighting and décor at City facilities and throughout the City in an estimated annual budgeted amount of \$75,500.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Commission of the City of North Miami Beach, Florida:

RESOLUTION NO. R2022

Section 1. The aforementioned recitals are true and correct.

Section 2. The Mayor and City Commission hereby authorize the City Manager or designee to enter into an agreement with CDI Enterprises, LLC dba Christmas Designers for the purchase holiday lighting and décor at City facilities and throughout the City in an estimated annual budgeted amount of \$75,500.

Section 3. The Mayor and City Commission also authorize the City Manager or designee to do all things to effectuate this resolution provided that any contract is reviewed by the City Attorney for legal sufficiency.

Section 4. This resolution shall take effect immediately upon approval.
