

RESOLUTION NO. R2022-XX

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF NORTH MIAMI BEACH, FLORIDA, AUTHORIZING CITY STAFF TO NEGOTIATE AN INTERLOCAL AGREEMENT WITH MIAMI DADE COUNTY AND AVENTURA MALL TO EXTEND TROLLEY SERVICES TO THE GOLDEN GLADES TRANSPORTATION MODAL AND AVENTURA MALL; PROVIDING THE CITY MANAGER AND THE CITY ATTORNEY WITH THE AUTHORITY TO DO ALL THINGS NECESSARY EFFECTUATE THIS RESOLUTION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of North Miami Beach currently runs a 4-route shuttle system that provides free shuttle service throughout the City which covers most of the city with one transfer, with service being paid for by City Citizens' Independent Transportation Trust (CITT funds); and

WHEREAS, in an effort to provide additional services which may be beneficial to its residents, the City is evaluating a pilot route for direct shuttle service between the Golden Glades Park & Ride and Aventura Mall; and

WHEREAS, the Miami Dade County Golden Glades Transportation Modal provides access for Tri-Rail and Miami-Dade Transit buses routes E, 22, 77, 155, 246, 277, and 95, which the Florida Department of Transportation developed it in coordination with Miami Dade County; and

WHEREAS, Aventura Mall is the premier shopping destination in South Florida with 300 stores, a food hall, and a rooftop venue and it is centrally located between Miami and Fort Lauderdale, and draws from a 50+ mile radius; and

WHEREAS, the stops developed were based on evaluation of existing routes, including ridership data collection from the trolley company to determine appropriate transfer locations; and

WHEREAS, the Miami-Dade Transit bus routes were also considered, along with Tri Rail's timetable, as part of the pilot route's timing and development. The pilot route's timetable was adjusted to optimize transfer wait times and provide for a buffer where needed, and can be found in Exhibit A; and

WHEREAS, the City of North Miami Beach, Miami-Dade County and Aventura Mall desire to enter into an interlocal agreement to facilitate the extension of trolley services to the Golden Glades Transportation Modal and Aventura Mall.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Commission of the City of North Miami Beach, Florida, that:

Section 1. The aforementioned recitals are true and correct and hereby incorporated.

Section 2. The City Commission hereby authorizes the City Manager or designee to negotiate and execute an interlocal agreement with Miami-Dade County and Aventura Mall to

facilitate the extension of trolley services to the Golden Glades Transportation Modal and Aventura Mall.

Section 3. The City Commission hereby authorizes the City Manager and City Attorney with the authority to do all things necessary to effectuate this resolution.

Section 4. This Resolution shall become effective immediately upon its approval.
