

**RESOLUTION NO. R2022-XX**

**A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF NORTH MIAMI BEACH, FLORIDA, APPROVING A CHANGE ORDER FOR REXEL USA, INC.; INCREASING THE CONTRACT'S ANNUAL EXPENDITURE BY AN ADDITIONAL \$25,386 FOR THE PURCHASE OF ALLEN BRADLEY PARTS & SERVICE AND ROCKWELL AUTOMATION EQUIPMENT; AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE THE CHANGE ORDER; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the City entered into an agreement with Rexel USA, Inc. for the purchase of Allen Bradley and Rockwell Automotive Parts & Services; and

**WHEREAS**, pursuant to Resolution No. R2021-123, the agreement was approved in an estimated expenditure amount of \$80,000; and

**WHEREAS**, NMB Water Department has requested additional purchase allocation, for Allen Bradley and Rockwell Automotive Parts & Services; and

**WHEREAS**, the Change Order increases the amount to purchase Allen Bradley and Rockwell Automotive Parts & Services to an additional \$25,386; and

**WHEREAS**, Section 3-3.20 *Change Orders* requires that change orders exceeding 10% or \$50,000.00, whichever is less, shall be approved by the City Commission; and

**WHEREAS**, the City Manager, conducted his own due diligence and concurs with the recommendation of the Water Department Director and the Chief Procurement Office to approve a change order to continue the purchase of Allen Bradley and Rockwell Automotive Parts & Services and increase the agreement amount by \$25,386 through the end of fiscal year 2022; and

**WHEREAS**, the Mayor and City Commission determine it is in the best interest of the City to increase the annual expenditure by an additional \$25,386.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Commission of the City of North Miami Beach, Florida:

**Section 1.** The aforementioned recitals are true and correct.

**Section 2.** The Mayor and City Commission hereby authorize the City Manager or designee to execute the Change Order in an amount not to exceed \$25,386 in annual expenditure.

**Section 3.** This resolution shall take effect immediately upon approval.
