## **RESOLUTION NO. R2022--**

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF NORTH MIAMI BEACH, FLORIDA, APPROVING WORK ORDER #4 BETWEEN THE CITY OF NORTH MIAMI BEACH AND BACK & VEATCH CORPORATION TO PROVIDE PROGRAM MANAGEMENT AND STAFF AUGMENTATION IN THE AMOUNT NOT TO EXCEED \$524,617.00 ATTACHED HERETO AS EXHIBIT "A"; AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE WORK ORDER #4 AND TO ISSUE NOTICE TO PROCEED RELATING TO WORK ORDER #4; AND PROVIDING AN EFFECTIVE DATE.

- **WHEREAS**, the City of North Miami Beach ("City") issued Request for Qualification No. 19-099-DR ("RFQ") for NMB Water Capital Improvement Program Management Support; and
- **WHEREAS,** pursuant to Resolution No. R2020-41, an agreement with Black & Veatch was approved in an amount not to exceed \$1,395,259.00. Subsequently, the City's Commission approved Work Orders No. 2 and 3 for \$4,318,689.66 (R2020-117) and for \$4,693,552.72 (R2022-91) respectively; and
- **WHEREAS**, the Public Works Department has identified a need for Staff Augmentation and Project Management Support Services to carryout pending projects throughout the City to ensure safety and compliance with County and State entities in an amount not to exceed \$524,617.00; and
- WHEREAS, the Public Works Department has requested an increase in purchase authorization; and
- **WHEREAS,** Section 3-3.14 of the City Code of Ordinances provides that contracts in excess of fifty thousand dollars (\$50,000.00) shall be awarded by the City Commission; and
- WHEREAS, the City Manager, Public Works Director and Chief Procurement Officer recommend that the City Commission approve and authorize the City Manager or designee to expend an additional \$524,617.00 for the purchase of Staff Augmentation and Project Management Support Services; and
- WHEREAS, the Mayor and City Commission determine it is in the best interest of the City to authorize the City Manager or designee to expend an additional \$524,617.00 for the purchase of Staff Augmentation and Project Management Support Services.
- **NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Commission of the City of North Miami Beach. Florida:
  - **Section 1.** The aforementioned recitals are true and correct.
- **Section 2.** The Mayor and City Commission hereby approve work order #4 with Black & Veatch and authorize the City Manager or designee to expend an additional \$524,617.00 for the purchase of Staff Augmentation and Project Management Support Services for the Public Works Department.
  - **Section 3.** This resolution shall take effect immediately upon approval.
