

RESOLUTION NO. R2023-XX

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF NORTH MIAMI BEACH, FLORIDA, APPROVING AND AUTHORIZING THE CITY MANAGER OR DESIGNEE TO PIGGYBACK THE CITY OF ST. PETERSBURG, FLORIDA'S CONTRACT WITH LMK PIPE RENEWAL LLC, FOR AS NEEDED WASTEWATER SEWER LINE EMERGENCY REPAIRS IN AN ESTIMATED ANNUAL AMOUNT OF \$65,000 AND IF APPLICABLE, TO RENEW THE PIGGYBACK SUBJECT TO APPROVED BUDGET APPROPRIATION AND AVAILABILITY OF FUNDS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, in line with the City of North Miami Beach's ("City"), Public Utilities Department ("NMB Water") provides water service within the City of North Miami Beach, Aventura, Miami Gardens, Sunny Isles and parts of Unincorporated Miami-Dade County; and

WHEREAS, in order to maintain the NMB Water treatment process and provide water services to our customers, NMB Water requires a services contractor for as needed emergency repairs to wastewater sewer lines; and

WHEREAS, the City identifies contracts competitively solicited and awarded by other governmental agencies as a favorable procurement method which is in line with the City's Strategic Plan mission of providing excellent municipal services in a financially responsible manner; and

WHEREAS, the City of St. Petersburg, Florida, issued Invitation for Bids No.7737, for annual CIPP lining services. LMK Pipe Renewal LLC, ("LMK Pipe") was awarded the Invitation for Bids for a three-year term, with an option to renew for one (1) additional two (2) year term; and

WHEREAS, Section 3-4.3 of the City's Code of Ordinances allows for the use of other governmental entities' contracts upon a determination that the supplies, materials, equipment or contractual services needed by the City were purchased using solicitation procedures which are substantially equivalent to the City's Purchasing Guidelines; and

WHEREAS, Section 3-3.14 of the City's Code of Ordinances provides that contracts in excess of fifty thousand dollars (\$50,000.00) shall be awarded by the City Commission; and

WHEREAS, the City Manager, the NMB Water Director and Chief Procurement Officer recommend that the City Commission approve and authorize the City Manager or designee to piggyback the City of St. Petersburg, Florida's Contract with LMK Pipe for as needed emergency repairs to wastewater sewer lines in an estimated annual budget amount of \$65,000; and

WHEREAS, the Mayor and City Commission believe it is in the best interests of the City to authorize the City Manager or designee to piggyback the City of St. Petersburg, Florida's

Contract with LMK Pipe, for as needed emergency repairs to wastewater sewer lines in an estimated annual budgeted amount of \$65,000 and if applicable, authorize the City Manager or designee to renew the piggyback subject to approved budget appropriation and availability of funds.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Commission of the City of North Miami Beach, Florida:

Section 1. The aforementioned recitals are true and correct.

Section 2. The Mayor and City Commission hereby authorize the City Manager or designee to piggyback the City of St. Peterburg, Florida's Contract with LMK, for as needed emergency repairs to wastewater sewer lines in an estimated annual budgeted amount of \$65,000 and if applicable, authorize the City Manager or designee to renew the agreement subject to approved budget appropriation and availability of funds.

Section 3. This resolution shall take effect immediately upon approval.
