

**RESOLUTION NO. R2023--**

**A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF NORTH MIAMI BEACH, FLORIDA, APPROVING AND AUTHORIZING THE CITY MANAGER OR DESIGNEE TO ISSUE A SOLE SOURCE PURCHASE ORDER TO AFTON PUMPS, INC. FOR THE PURCHASE OF WELL PUMPS AND MOTORS IN AN ESTIMATED BUDGETED AMOUNT OF \$295,000; AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXPEND SAID AMOUNT; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, in keeping with the City of North Miami Beach’s (“City”) Strategic Plan of providing a safe environment for residents and visitors to the City, and being fiscally responsible, it is NMB Wastewater’s mission to maintain operations by preventing emergency situations resulting from equipment failure or severe weather natural disasters; and

**WHEREAS**, NMB Water operates both an Afton Floridan and Biscayne Well Pump and Motor at the water plant for the RO and NANO treatment system. This is essential equipment that pumps water from the underground well into a storage tank where the first state of water treatment begins; and

**WHEREAS**, the City has solicited the assistance of Afton Pumps, Inc. (“AFTON”) for the purchase of two (2) Floridan WP-1F Model VST 10x12-3 Pumps and one (1) Biscayne WP-13B Model VST 12x16-2 (“Pumps”); and

**WHEREAS**, Section 3-4.5 a. Exemption From Bidding of the City’s Code of Ordinances provides sole-source supplies and services, such as unique, patented, or franchised supplies or services, are exempt from bidding if the Purchasing Agent determines, after conducting a good faith review of available sources, that the particular supply or service is available from only one (1) source; and

**WHEREAS**, Section 3-3.14 of the City’s Code of Ordinances provides that contracts in excess of fifty thousand dollars (\$50,000.00) shall be awarded by the City Commission; and

**WHEREAS**, the City Manager, the NMB Water Director and Chief Procurement Officer recommend that the City Commission approve and authorize the City Manager or designee to enter issue a sole source purchase order to AFTON for the purchase of a Pumps in an estimated budgeted amount of \$295,000; and

**WHEREAS**, the Mayor and City Commission believe it is in the best interests of the City to authorize the City Manager or designee to issue a sole source purchase order to AFTON for the purchase of a Pumps in an estimated budgeted amount of \$295,000.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Commission of the City of North Miami Beach, Florida:

**RESOLUTION NO. R2023**

**Section 1.** The aforementioned recitals are true and correct.

**Section 2.** The Mayor and City Commission hereby authorize the City Manager or designee to issue a sole source purchase order to Afton Pumps, Inc. for the purchase of Model VST 10x12-3 Pumps in an estimated budgeted amount of \$295,000.

**Section 3.** This resolution shall take effect immediately upon approval.
