A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF NORTH MIAMI BEACH, FLORIDA, RENAMING AND CODESIGNATION OF THE PORTION OF S. GLADES DR. (NE 165 ST) BETWEEN SOUTH MIAMI DRIVE TO NE 21ST AVE AS “ST. FORT DRIVE”; AUTHORIZING THE CITY MANAGER OR DESIGNEE TO TAKE NECESSARY ACTIONS; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR CONFLICTS; PROVIDING FOR SCRIVENER ERRORS, PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AND EFFECTIVE DATE

WHEREAS, The St. Fort Family has been delivering healing experiences to the North Miami Beach community since 1980; and

WHEREAS, the family owned and operated for over two decades. St. Fort’s Funeral Home., a premier North Miami Beach funeral home serving all South Florida including Dade, Broward, Monroe, Palm Beach Counties, and beyond; and

WHEREAS, the Mayor and Commission desire to publicly recognize The St. Fort Family for their efforts and contributions to the North Miami Beach community, by renaming and codesignation of the portion of S. Glades Dr. (Ne 165 St.) between South Miami Drive to NE 21st Ave as “St. Fort Drive”; and

WHEREAS, the Mayor and City Commission also urge the Miami-Dade Commission to co-designate and rename S. Glades Dr. (NE 165 St.) from South Miami Drive to NE 21st Ave as “St. Fort Drive”.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF NORTH MIAMI BEACH, FLORIDA, THAT:

Section 1. Recitals. The foregoing recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference

Section 2. Designation. The portion of S. Glades Dr. (NE 165 St.) from South Miami Drive to NE 21st Ave. is hereby renamed and co-designated as “St. Fort Drive”.

Section 3. Authorization. The City Manager or designee is authorized to do all things necessary to effectuate this Resolution.

Section 4. Implementation. The City Manager and City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of the Resolution.

Section 5. All Resolutions or parts of Resolutions in conflict with this Resolution are repealed to the extent of such conflict.

Section 6. Any scrivener or typographical errors that do not affect intent may be corrected with notice to, and the authorization of the City Attorney and City Manager without further process.

Section 7. If any provision of this Resolution or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of this Resolution that can be given affect without the invalid provision or application, and to this end the provisions of this Resolution are declared to be severable.

Section 8. **Effective Date.** This Resolution shall become effective immediately upon approval.
