A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF NORTH MIAMI BEACH, FLORIDA, AUTHORIZING THE CITY MANAGER TO APPLY FOR GRANT ASSISTANCE UNDER THE FLORIDA DEPARTMENT OF TRANSPORTATION HIGHWAY BEAUTIFICATION GRANT AND TO FURTHER EXECUTE ANY SUBSEQUENT AGREEMENTS OR DOCUMENTS ASSOCIATED WITH THE GRANT AND REIMBURSEMENT OF PROJECT FROM THE FDOT TO THE CITY; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, certain roadside areas and median strips within the Florida Department of Transportation's ("FDOT") rights of way in the City of North Miami Beach must be maintained and attractively landscaped;

WHEREAS, the Mayor and City Commission of the City of North Miami Beach routinely beautify and improve such rights of way by landscaping;

WHEREAS, FDOT financial assistance is required for the program mentioned above; and

WHEREAS, the Mayor and City Commission of the City of North Miami Beach desire to authorize the Public Works Department to apply for a Beautification Grant from FDOT, and if awarded, to accept the grant, and enter into a Beautification Grant, Landscape Construction, and Maintenance Memorandum of Agreement for Phase 1 between the City of North Miami Beach, and FDOT.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF NORTH MIAMI BEACH, FLORIDA, THAT:

Section 1. The foregoing recitals are adopted and hereby incorporated as if fully set

forth herein.

Section 2. The Mayor and the City Commission, hereby authorize the City Manager to do all things necessary to effectuate application to FDOT for a grant in the amount of \$100,000.00, which represents the cost of the routine beautification of FDOT rights of way undertaken by the City of North Miami Beach.

Section 3. If any provision, section, phrase, or word of this Resolution is declared invalid or unenforceable by a court of competent jurisdiction, the remaining provisions, sections, phrases or words of this Resolution shall remain in full force and effect.

Section 4. This Resolution shall become effective immediately upon its adoption.

Section 5. The City Clerk of City of North Miami Beach is hereby directed to send copies of this Resolution to FDOT and all other parties as directed by the Mayor and the City Commission.
