

RESOLUTION NO. 2025-XX

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF NORTH MIAMI BEACH, FLORIDA, APPROVING PURCHASE ORDERS BETWEEN THE CITY AND MULTIPLE VENDORS FOR THE PURCHASE OF WATER METER FITTINGS AND WATER LINE ACCESSORIES; FOR AN ANNUAL BUDGETED AMOUNT NOT TO EXCEED \$690,000; AUTHORIZING THE CITY MANAGER OR DESIGNEE TO DO ALL THINGS NECESSARY TO EFFECTUATE THIS RESOLUTION; PROVIDING FOR CONFLICTS; PROVIDING FOR SCRIVENER ERRORS, PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, pursuant to Chapter 166, *Florida Statutes* and Section 1.4 of the Charter of the City of North Miami Beach (“City”), the City shall have all available governmental, corporate, and proprietary powers and may exercise them except when prohibited by law; and

WHEREAS, Section 3-2.2 of the City of North Miami Beach Code of Ordinances (“Code”) provides that the Chief Procurement Officer has the authority to join with other governmental entities in cooperative purchasing plans, when the best interests of the City would be served; and

WHEREAS, To maintain NMB Water Department’s treatment processes and ensure continued water service to customers, the Department requires the purchase of various manufactured water meter fittings, water line accessory replacement parts, and operating equipment; and

WHEREAS, the specific piggyback contracts anticipated to meet the City’s operational needs are as follows:

WHEREAS, pursuant to Section 3-3.14 of the Code, the City Manager has the authority to approve purchases and awards up to fifty thousand dollars (\$50,000), and any expenditure above this amount need to be presented to the Mayor and City Commission for approval; and

WHEREAS, the City Manager and the Chief Procurement Officer recommend that the City Commission approve multiple purchase orders in an annual budgeted amount not to exceed \$690,000

for water meter fittings and water line accessories with Ferguson US Holdings, Inc., Fortiline, Inc., Consolidated Pipe and Supply Company, and Core & Main; and

WHEREAS, the Mayor and City Commission determine it is in the best interests of the City to approve multiple purchase orders in an annual budgeted amount not to exceed \$690,000 for the purchase of water meter fittings and water line accessories with Ferguson US Holdings, Inc., Fortiline, Inc., Consolidated Pipe and Supply Company, and Core & Main.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF NORTH MIAMI BEACH, FLORIDA, THAT:

Section 1. The foregoing whereas clauses are true and correct and adopted as the legislative and administrative findings of the City Commission and made a specific part of this Resolution; all exhibits attached hereto are made a specific part of this Resolution.

Section 2. The purchase orders with Ferguson US Holdings, Inc., Fortiline, Inc., Consolidated Pipe and Supply Company, and Core & Main, in substantially the form attached as Exhibit "A" for an annual budgeted amount not to exceed \$690,000, for the purchase of water meter fittings and water line accessories, subject to budget appropriation and availability of funds is hereby approved.

Section 3. The City Manager or designee is authorized to execute the purchase agreements and to renew the agreements and expend budgeted funds in furtherance hereof, subject to approved budget appropriation and availability of funds.

Section 4. All Resolutions or parts of Resolutions in conflict with this Resolution are repealed to the extent of such conflict.

Section 5. Any scrivener or typographical errors that do not affect intent may be corrected with notice to, and the authorization of the City Attorney and City Manager without further process.

Section 6. If any provision of this Resolution or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of this Resolution that can be given effect without the invalid provision or application, and to this end the provisions of this Resolution are declared to be severable.

Section 7. This Resolution shall take effect immediately upon adoption.
