A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF NORTH MIAMI BEACH, FLORIDA, APPROVING A PURCHASE ORDER BETWEEN THE CITY AND AVI-SPC LLC, FOR THE PURCHASE AND INSTALLATION OF AUDIO-VISUAL EQUIPMENT; IN A BUDGETED AMOUNT NOT TO EXCEED \$117,070; AUTHORIZING THE CITY MANAGER OR DESIGNEE TO DO ALL THINGS NECESSARY TO EFFECTUATE THIS RESOLUTION; PROVIDING FOR CONFLICTS; PROVIDING FOR SCRIVENER ERRORS, PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, pursuant to Chapter 166, *Florida Statutes* and Section 1.4 of the Charter of the City of North Miami Beach (“City”), the City shall have all available governmental, corporate, and proprietary powers and may exercise them except when prohibited by law; and

WHEREAS, Section 3-2.2 of the City of North Miami Beach Code of Ordinances (“Code”) provides that the Chief Procurement Officer has the authority to join with other governmental entities in cooperative purchasing plans, when the best interests of the City would be served; and

WHEREAS, Omnia Partners, a national cooperative purchasing program, through its Lead Agency, Region 4 Education Service Center, awarded Contract No. R201201 for Audio Visual Equipment, Accessories, and Services to AVI-SPL LLC (“AVI”) effective April 1, 2021, through March 31, 2024, and subsequently renewed the contract through March 31, 2026 (“Piggyback Contract”); and

WHEREAS, the City’s Parks and Recreation Department desires to upgrade the audio-visual capabilities of one of its facility conference rooms, as the existing audiovisual system is outdated and requires a complete replacement to ensure reliable and modern functionality; and

WHEREAS, enhanced audio-visual technology will improve the City’s ability to conduct meetings, training sessions, and public presentations, while enabling hybrid participation that supports greater efficiency, accessibility, and communication for local community organizations, educational initiatives, and neighborhood associations that rely on the facility for collaborative activities; and

WHEREAS, pursuant to Section 3-3.14 of the City Code, the City Manager has the authority to approve purchases and awards up to fifty thousand dollars (\$50,000), and any expenditure above this amount need to be presented to the Mayor and City Commission for approval; and

WHEREAS, the City Manager and the Chief Procurement Officer recommend that the City Commission approve a Purchase Order in a budgeted amount not to exceed \$117,070 for the purchase and installation of audio-visual equipment; and

WHEREAS, the Mayor and City Commission determine it is in the best interests of the City

to approve a Purchase Order in a budgeted amount not to exceed \$117,070 for purchase and installation of audio-visual equipment from AVI-SPL LLC.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF NORTH MIAMI BEACH, FLORIDA, THAT:

Section 1. The foregoing whereas clauses are true and correct and adopted as the legislative and administrative findings of the City Commission and specifically made part of this Resolution; all exhibits attached hereto are made a specific part of this Resolution.

Section 2. The price quote from AVI-SPL LLC. in substantially the form attached as Exhibit "A", in a budgeted amount not to exceed \$117,070, for the purchase and installation of audio-visual equipment for the Parks and Recreation Department, subject to budget appropriation and availability of funds, is hereby approved.

Section 3. The City Manager or designee is authorized to do all things necessary to effectuate this Resolution.

Section 4. All Resolutions or parts of Resolutions in conflict with this Resolution are repealed to the extent of such conflict.

Section 5. Any scrivener or typographical errors that do not affect intent may be corrected with notice to, and the authorization of the City Attorney and City Manager without further process.

Section 6. If any provision of this Resolution or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of this Resolution that can be given effect without the invalid provision or application, and to this end the provisions of this Resolution are declared to be severable.

Section 7. This Resolution shall take effect immediately upon adoption.
