A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF NORTH MIAMI BEACH, FLORIDA, SETTING THE DATES FOR THE CITY COMMISSION MEETINGS FOR THE 2026 CALENDAR YEAR; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on November 8, 2016, the electorate approved amending the City of North Miami Beach's Charter to reduce the number of regular City Commission meetings to no less than 11 monthly meetings per year; and

WHEREAS, based upon previous meeting schedules the City Clerk with the City Manager has proposed the below schedule for the 2026 City Commission Meetings; and

WHEREAS, the 2026 schedule proposes the regular monthly City Commission meetings will usually be held on the third Tuesday of each month, except as noted below, beginning at 6:00 P.M. with an alternate date for an additional meeting to consider major Quasi-Judicial items if necessary, to be held the week following the regular City Commission Meetings as listed below. Meeting dates may be changed by a vote of a majority of the City Commission present and voting. Nothing herein shall affect the holding of Special Commission meetings, as necessary.
