

RESOLUTION NO. R2026--XX

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF NORTH MIAMI BEACH, FLORIDA, APPROVING TASK ORDERS FOR PROFESSIONAL ENGINEERING SERVICES FOR TRAFFIC CALMING STUDIES, DESIGN, AND PERMITTING AT VARIOUS LOCATIONS WITHIN THE CITY IN AN AMOUNT NOT TO EXCEED \$163,500.00, WITH CHEN MOORE AND ASSOCIATES, INC., UNDER THE “CONTINUING SERVICES AGREEMENT” FOR PROFESSIONAL CONSULTING SERVICES; AND AUTHORIZING THE CITY MANAGER OR DESIGNEE TO DO ALL THINGS NECESSARY TO EFFECTUATE THIS RESOLUTION; PROVIDING FOR CONFLICTS; AND SUBJECT TO THE BUDGET APPROPRIATION AND AVAILABILITY OF FUNDS; PROVIDING FOR SCRIVENER’S ERRORS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, pursuant to Chapter 166, Florida Statutes and Section 1.4 of the Charter of the City of North Miami Beach (“City”), the City shall have all available governmental, corporate, and proprietary powers and may exercise them except when prohibited by law; and

WHEREAS, on July 21, 2020, the City Commission approved Resolution R2020-62 for RFQ-19-082-MC “Continuing Services Agreement for Architectural/Engineering, Landscape Architect and Surveying Services,” and subsequently executed agreements with the ranked firms that met the qualifications and provided firm pricing under the solicitation specifications, including an agreement with Chen Moore & Associates, Inc. (“*Chen Moore*”) on December 21, 2020; and

WHEREAS, pursuant to Resolution R2022-98, the City Commission approved RFQ-22-018-MC “Acquisition of Professional Architectural & Engineering Services,” authorizing existing contracts under RFQ-19-082-MC to be co-termed with the latest agreement through September 30, 2027 (“*Continuing Services Agreement*”); and

WHEREAS, the Public Works Department desires to utilize Chen Moore to conduct traffic calming studies and provide recommendations for various traffic calming initiatives at locations throughout the City; and

WHEREAS, based on the findings of previous studies, Chen Moore will also provide professional engineering services, including design and preparation of construction documents, to implement the recommended traffic calming improvements within the City; and

WHEREAS, Section 3-3.14 of the Code of Ordinances City of North Miami Beach, Florida, 2008 (Code”) provides that contracts more than fifty thousand dollars (\$50,000.00) shall be awarded by the City Commission; and

WHEREAS, the City Manager and the Chief Procurement Officer recommend that the City Commission approve and authorize the City Manager or designee to approve the Task Orders with Chen Moore in an amount not to exceed \$163,500.00 to provide professional engineering services for traffic calming improvements throughout the City; and

WHEREAS, the Mayor and City Commission believe it is in the best interests of the City to authorize the City Manager or designee to approve Task Orders with Chen Moore in an amount not to exceed \$163,500.00 to provide professional engineering services for traffic calming improvements throughout the City.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF NORTH MIAMI BEACH, FLORIDA:

Section 1. The foregoing whereas clauses are true and correct and adopted as the legislative and administrative findings of the City Commission and made a specific part of this Resolution; all exhibits attached hereto are made a specific part of this Resolution.

Section 2. The Task Orders with Chen Moore and Associates, Inc., in an amount not to exceed \$163,500.00 to provide professional engineering services for traffic calming improvements throughout the City, in substantially the form attached as Exhibit “A,” is approved and the City Manager or designee is authorized to issue a purchase order and execute the Task Order on behalf of the City.

Section 3. The City Manager or designee is authorized to do all things necessary to effectuate this Resolution.

Section 4. All Resolutions or parts of Resolutions in conflict with this Resolution are repealed to the extent of such conflict.

Section 5. Any scrivener or typographical errors that do not affect intent may be corrected with notice to, and the authorization of the City Attorney and City Manager without further process.

Section 6. If any provision of this Resolution or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of this Resolution that can be given effect without the invalid provision or application, and to this end the provisions of this Resolution are declared to be severable.

Section 7. This Resolution shall take effect immediately upon adoption.
