A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF NORTH MIAMI BEACH, FLORIDA, AUTHORIZING CITY TO ENTER INTO A MEMORANDUM OF UNDERSTANDING WITH BIG BROTHERS BIG SISTERS OF MIAMI, INC. TO PROVIDE MENTORING SERVICES TO HIGH SCHOOL AGED YOUTH WHO ARE RESIDENTS OF THE CITY OF NORTH MIAMI BEACH; PROVIDING FOR THE APPROVAL OF THE MEMORANDUM OF UNDERSTANDING WITH BIG BROTHERS BIG SISTERS OF MIAMI, INC.; AUTHORIZING THE CITY MANAGER OR DESIGNEE TO DO ALL THINGS NECESSARY TO EFFECTUATE THIS RESOLUTION; PROVIDING FOR CONFLICTS; PROVIDING FOR SCRIVENER ERRORS, PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Mayor and City Commission desire to enter into a collaborative relationship between the City of North Miami Beach and Big Brothers Big Sisters of Miami, Inc. (“BBBS Miami”); and

WHEREAS, the City would like to enter into a Memorandum of Understanding (“MOU”) with BBBS Miami, to provide one-to-one mentoring services to high school aged youth who are residents of the City of North Miami Beach; and

WHEREAS, the Mayor and City Commission hereby find the MOU between BBBS Miami and the City, attached hereto as Exhibit “A”, and made a part of this Resolution, to be in the best interest of the City and BBBS Miami.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF NORTH MIAMI BEACH, FLORIDA, THAT:

Section 1. The foregoing whereas clauses are true and correct and adopted as the legislative and administrative findings of the City Commission and made a specific part of this Resolution; all exhibits attached hereto are made a specific part of this Resolution.

Section 2. The Mayor and the City Commission hereby approve the MOU between BBBS Miami and the City, in substantially the form attached hereto as Exhibit “A”.

Section 3. The City Manager or designee is authorized to do all things necessary to effectuate this Resolution.

Section 4. All Resolutions or parts of Resolutions in conflict with this Resolution are repealed to the extent of such conflict.

Section 5. Any scrivener or typographical errors that do not affect intent may be corrected with notice to, and the authorization of the City Attorney and City Manager without further

Section 6. If any provision of this Resolution or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of this Resolution that can be given affect without the invalid provision or application, and to this end the provisions of this Resolution are declared to be severable.

Section 7. This Resolution shall take effect immediately upon adoption.
