A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF NORTH MIAMI BEACH, FLORIDA, APPROVING AND AUTHORIZING THE USE OF CITY FACILITIES AND LIMITED CITY RESOURCES FOR THE “FREE \$1,000 FOR YOUR FUTURE” COMMUNITY WORKSHOP HOSTED BY COMMISSIONER LYNN SU; AUTHORIZING THE CITY MANAGER OR DESIGNEE TO PROVIDE ADMINISTRATIVE SUPPORT AND COORDINATION RELATED TO THE EVENT; PROVIDING FOR CONFLICTS; PROVIDING FOR SCRIVENER’S ERRORS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, The Mayor and City Commission of the City of North Miami Beach (the “City”) recognize the importance of promoting financial literacy, retirement preparedness, and educational opportunities that support long-term financial stability for residents and families; and

WHEREAS, Commissioner Lynn Su seeks to host a community workshop titled “Free \$1,000 for Your Future” on June 11, 2026, at the McDonald Center located in the City; and

WHEREAS, the workshop is intended to provide educational information to residents regarding savings opportunities, retirement planning initiatives, tax-advantaged savings strategies, and available federal programs that may benefit eligible individuals and families; and

WHEREAS, representatives from government agencies, financial institutions, and community organizations may participate in the workshop for informational and educational purposes; and

WHEREAS, the City Commission finds that facilitating community educational workshops that promote financial awareness and civic engagement serves a valid public purpose and benefits the residents of the City; and

WHEREAS, the City desires to authorize the use of City facilities and limited City resources, including coordination assistance from Parks and Recreation and communications support for public outreach related to the event.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF NORTH MIAMI BEACH, FLORIDA, THAT:

Section 1. The foregoing whereas clauses are true and correct and adopted as the legislative and administrative findings of the City Commission and made a specific part of this Resolution.

Section 2. The Mayor and City Commission hereby approve and authorize the use of the McDonald Center and limited City resources necessary to facilitate the “Free \$1,000 for Your Future” community workshop scheduled for June 11, 2026.

Section 3. The City Manager or designee is authorized to coordinate administrative support

related to the event, including communications assistance, facility coordination, and other logistical support deemed necessary and appropriate.

Section 4. Participation by outside organizations, financial institutions, or governmental representatives in the workshop shall be for informational and educational purposes only and shall not constitute an endorsement by the City of North Miami Beach of any private entity, financial product, or investment service.

Section 5. All Resolutions or parts of Resolutions in conflict with this Resolution are repealed to the extent of such conflict.

Section 6. Any scrivener or typographical errors that do not affect intent may be corrected with notice to, and the authorization of the City Attorney and City Manager without further process.

Section 7. If any provision of this Resolution or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of this Resolution that can be given effect without the invalid provision or application, and to this end the provisions of this Resolution are declared to be severable.

Section 8. This Resolution shall take effect immediately upon adoption.
