A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF NORTH MIAMI BEACH, FLORIDA, AWARDING REQUEST FOR PROPOSAL 20-019-DR - "NORTH MIAMI BEACH TROLLEY MAINTENANCE **OPERATION** AND SERVICES", TO PRO TRANSPORTATION INC. D/B/A PROKEL MOBILITY; AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT FOR THE PURCHASE CONTEMPLATED HEREIN AND TO EXPEND BUDGETED FUNDS **FURTHERANCE HEREOF:** IN PROVIDING FOR **IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

WHEREAS, the City of North Miami Beach ("City") issued Awarding Request for Proposal 20-019-Dr – "North Miami Beach Trolley Operation And Maintenance Services" (the "RFP"); and

WHEREAS, electronic notices were posted on the City's website and Bidsync.com, and notifications were sent to over 6,974 potential local and national vendors, and on June 24, 2020, four (4) bids were received by the City; and

WHEREAS, the Evaluation Committee reviewed the proposals and ranked Limousines of

South Florida, Inc. and Pro Transportation Inc. d/b/a ProKel Mobility; and

WHEREAS, the City Manager conducted his own due diligence on the two top ranked

companies and has recommended ProKel Mobility ; and

WHEREAS, the Mayor and City Commission find it to be in the best interests of the City

to award the RFP to ProKel Mobility and authorize the City Manager or designee to execute an agreement in furtherance hereof.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF NORTH MIAMI BEACH, FLORIDA:

Section 1. <u>Recitals.</u> The foregoing recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

<u>Section 2.</u> <u>Award.</u> Request for Proposal 20-019-Dr – "North Miami Beach Trolley Operation And Maintenance Services" is hereby awarded to Pro Transportation Inc. d/b/a ProKel Mobility. This award, in and of itself, does not vest ProKel Mobility with any contractual rights, absent entering an agreement with the City.

<u>Section 3.</u> <u>Authorization.</u> The City Manager is authorized to finalize and execute an agreement with ProKel Mobility designee for the purchase contemplated herein and to expend budgeted funds in furtherance hereof.

Section 4. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

Section 5. Effective Date. This resolution shall take effect immediately upon approval.
