

**RESOLUTION NO. 2020-119**

**A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF NORTH MIAMI BEACH, FLORIDA, PURSUANT TO SECTION 3-4.3 OF THE CITY CODE OF ORDINANCES, APPROVING PURCHASE ORDER FROM BARTOW FORD CO., VIA CHARLOTTE COUNTY BID NO. 2018000509, FOR THE PURCHASE OF POLICE VEHICLES IN AN ESTIMATED BUDGETED AMOUNT OF \$453,000.00; AUTHORIZING THE CITY MANAGER TO EXECUTE THE PURCHASE ORDER AND EXPEND BUDGETED FUNDS IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, in line with the City of North Miami Beach’s (“City”) Strategic Plan mission of providing excellent municipal services and a being beautiful, safe and livable community in South Florida, the North Miami Beach Police Department requires the purchase of seven (7) Ford Explorer Interceptors for Road Patrol, two (2) Ford Transit Cargo Vans for Crime Scene Investigations and three (3) Ford Escapes for Community Service Operations, (“Police Vehicles”); and

**WHEREAS**, the City identifies contracts competitively solicited and awarded by other governmental agencies as a favorable procurement method which is in line with the City’s Strategic Plan mission of providing excellent municipal services in a financially responsible manner; and

**WHEREAS**, Charlotte County, Florida, issued Invitation to Bid No. 2018000509, “Vehicles – Annual Contract” (“ITB”), for the purchase of vehicles, and on September 25, 2018, Bartow Ford, Co. (“Bartow Ford”)” was awarded the ITB for a one (1) year term, with options to renew for two (2) additional one (1) year terms; the first renewal option was executed through

September 30, 2019, and the second and final renewal option has been approved through September 30, 2021;

**WHEREAS**, Section 3-4.3 of the City's Code of Ordinances allows for the use of other governmental entities' contracts upon a determination that the supplies, materials, equipment or contractual services needed by the City were purchased using solicitation procedures which are substantially equivalent to the City's Purchasing Guidelines; and

**WHEREAS**, Section 3-3.14 of the City's Code of Ordinances provides that contracts in excess of fifty thousand dollars (\$50,000.00) shall be awarded by the City Commission; and

**WHEREAS**, the City Manager, the Chief of Police and the Chief Procurement Officer recommend that the City Commission approve and authorize the City Manager or designee to issue a purchase order Bartow Ford Co. for the purchase of Police Vehicles in an estimated budgeted amount of \$453,000; and

**WHEREAS**, the Mayor and City Commission believe it is in the best interests of the City to authorize the City Manager or designee to issue a purchase order to Bartow Ford Co. for the purchase of Police Vehicles in an estimated budgeted amount of \$453,000.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF NORTH MIAMI BEACH, FLORIDA:**

**Section 1.**     **Recitals.**   The foregoing recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2.**     **Approval.**   Pursuant to Section 3-4.3 of the City Code of Ordinances, the purchase of seven (7) Ford Explorer Interceptors for Road Patrol, two (2) Ford Transit Cargo Vans for Crime Scene Investigations and three (3) Ford Escapes for Community Service Operation for

the City Police Department, from Bartow Ford, Co., via Charlotte County Bid No. 2018000509, in an estimated budgeted amount of \$453,000.00, is hereby approved.

**Section 3. Authorization.** The City Manager is hereby authorized to execute the purchase order and to expend budgeted funds, in furtherance hereof.

**Section 4. Implementation.** The City Manager and City Attorney are hereby authorized to take such action as may be necessary to implement the purpose and provisions of this Resolution.

**Section 5. Effective Date.** This resolution shall take effect immediately upon approval.
