

RESOLUTION NO. R2021-

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF NORTH MIAMI BEACH, FLORIDA, APPROVING AN AGREEMENT WITH ENVIROWASTE SERVICES GROUP, INC., FOR WATER AND WASTEWATER MAINTENANCE SERVICES IN AN ESTIMATED BUDGETED AMOUNT OF \$600,000 FOR AN EIGHTEEN MONTH PERIOD; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, in line with the City of North Miami Beach's ("City") Strategic Plan of providing excellent municipal services and a high performing City organization providing exceptional water quality, Public Utilities Department ("NMB Water") provides water service within the City of North Miami Beach, Aventura, Miami Gardens, Sunny Isles and parts of Unincorporated Miami-Dade County; and

WHEREAS, in order to maintain the NMB Water treatment process and provide water services to its customers, NMB Water requires a services contractor for water and wastewater maintenance services, which includes but is not limited to, emergency or unforeseen maintenance and repairs, sewer/drain cleaning, manhole rehabilitation and replacement, CCTV inspection, and various consulting services; and

WHEREAS, the City identifies contracts competitively solicited and awarded by other governmental agencies as a favorable procurement method which is in line with the City's Strategic Plan mission of providing excellent municipal services in a financially responsible manner; and

WHEREAS, Section 3-4.3 of the City's Code of Ordinances allows for the use of other governmental entities' contracts upon a determination that the supplies, materials, equipment or contractual services needed by the City were purchased using solicitation procedures which are substantially equivalent to the City's Purchasing Guidelines; and

WHEREAS, the Village of Bal Harbour, Florida, issued Request for Proposals No. 2019-02, for qualified service providers for routine and emergency water and wastewater maintenance; and Envirowaste Services Group, Inc., ("Envirowaste") was awarded the RFP for a three year term, with options to renew for three (3) additional one (1) year terms; and

WHEREAS, Section 3-3.14 of the City's Code of Ordinances provides that contracts in excess of fifty thousand dollars (\$50,000.00) shall be awarded by the City Commission; and

WHEREAS, the City Manager, the NMB Water Director and the Chief Procurement Officer recommend that the City Commission approve and authorize the City Manager or designee to enter into an agreement with Envirowaste for water and wastewater maintenance services in an estimated budget amount of \$600,000 for eighteen months; and

WHEREAS, the Mayor and City Commission believe it is in the best interests of the City to authorize the City Manager or designee enter into an agreement with Envirowaste Services Group, Inc. for water and wastewater maintenance services in an estimated budget amount of \$600,000 for an eighteen-month period, and to renew the agreement subject to approved budget appropriation and availability of funds.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Commission of the City of North Miami Beach, Florida:

Section 1. Recitals Adopted. The aforementioned recitals are true and correct.

Section 2. Agreement Approved. The agreement with Envirowaste Services Group, Inc., in substantially the form attached as Exhibit “A,” for water and wastewater maintenance services in an estimated budget amount of \$600,000 for an eighteen-month period (the “Agreement”) is approved.

Section 3. Implementation. The City Manager or designee is authorized to execute and take any action necessary to implement the Agreement and the purposes of this Resolution, and to renew the Agreement subject to approved budget appropriation and availability of funds.

Section 4. Effective Date. This resolution shall take effect immediately upon approval.
