City Commission Meeting Minutes

ROLL CALL OF THE CITY OFFICIALS

The Regular Commission Meeting was called to order at 7:12 p.m. Present at the meeting in the Theatre were Mayor Anthony F. DeFillipo, Commissioner Fortuna Smukler, and Commissioner Paule Villard. Present at the meeting via zoom were Vice Mayor Michael Joseph, Commissioner McKenzie Fleurimond, Commissioner Daniela Jean, and Commissioner Barbara Kramer. City Manager Esmond Scott, Interim City Attorney Hans Ottinot, and City Clerk Andrise Bernard were also present.

City Attorney Hans Ottinot announced that there were meeting technical difficulties that did not allow for the meeting to be streamed and that therefore the meeting could not proceed, and that the agenda items would be deferred to the next City Commission meeting on February 25, 2021.
