Resolution R2025-114 Amending the Proposed Budget Hearing Dates for the Proposed Budget of Fiscal Year 2025-2026

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF NORTH MIAMI BEACH, FLORIDA, ESTABLISHING THE PROPOSED MAXIMUM MILLAGE RATE FOR THE LEVYING OF AD VALOREM TAXES FOR THE CITY OF NORTH MIAMI BEACH FOR FISCAL YEAR 2025-2026 COMMENCING OCTOBER 1, 2025, THE CALCULATED "ROLLED-BACK" RATE, AND AMENDING THE SCHEDULE FOR THE BUDGET PUBLIC HEARINGS ON THE CITY'S PROPOSED BUDGET FOR FISCAL YEAR 2025-2026; ESTABLISHING NEW DATES FOR THE FIRST AND SECOND PUBLIC BUDGET HEARINGS AS REQUIRED BY LAW; DIRECTING THE CITY CLERK AND CITY MANAGER TO TRANSMIT THIS RESOLUTION WITH THE PROPERTY APPRAISER OF

MIAMI-DADE COUNTY PURSUANT TO THE REQUIREMENTS OF SECTION 200.065, FLORIDA STATUTES AND THE RULES AND REGULATIONS OF THE DEPARTMENT OF REVENUE FOR THE STATE OF FLORIDA; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE.


Motion to **approve** Resolution R2025-114 made by Commissioner Smith, seconded by Vice Mayor Chernoff.
